Amend Henderson Municipal Code Chapter 7 Relating to the Sale of Dogs, Cats and Rabbits

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA, TO AMEND CHAPTER 7 OF THE HENDERSON MUNICIPAL CODE AND TO ADD CHAPTER 7.75 – TO LIMIT COMMERCIAL ANIMAL ESTABLISHMENTS THAT SELL DOGS, CATS, AND/OR RABBITS TO COMMERCIAL ANIMAL ESTABLISHMENTS THAT ALREADY HOLD PERMITS, AND TO PROHIBIT PERMITS FROM BEING ISSUED TO NEW COMMERCIAL ANIMAL ESTABLISHMENTS THAT SELL DOGS, CATS, AND/OR RABBITS WHICH DO NOT ALREADY HOLD PERMITS.
