Note: HMC Section 8.37.070 Outdoor Fire prohibited private land without permit: No person shall kindle or maintain any outdoor open fire or authorize any such fire to be kindled or maintained on any private land without first having obtained a permit from the fire department. Nor shall any fire be kindled or maintained in any outdoor container unless such container has been approved by and a permit issued by the fire department. Nothing in this section shall be construed to prohibit or make unlawful the construction and use of barbecue pits, grills or outdoor fireplaces for the preparation of food for consumption by individuals on their own private property or with the permission of the owner of the private property.
