

**LEGAL NOTICE**  
**MODIFY HMC 14.09.030**

**NOTICE BY THE CITY OF HENDERSON, NEVADA ("CITY") IN ACCORDANCE WITH 40 CFR PART 403 OF REQUEST TO UNITED STATES ENVIRONMENTAL PROTECTION AGENCY TO APPROVE MODIFICATION OF CITY'S PRETREATMENT PROGRAM THROUGH A PROPOSED ORDINANCE TO AMEND SECTION 14.09.030 OF THE HENDERSON MUNICIPAL CODE**

The City of Henderson, Nevada ("City") is requesting that the United States Environmental Protection Agency ("EPA") approve the City's modification of its pretreatment program. In accordance with 40 CFR Part 403 and EPA requirements, the City proposes to modify its program through a proposed ordinance that will amend the discharge limits in Section 14.09.030 in the Henderson Municipal Code (HMC) ("Ordinance"). The City submitted to the EPA for an informal review the draft Ordinance and a local limits submittal package and thereafter incorporated any required and recommended changes.

Interested and potentially interested persons may provide written comments to the City regarding the Ordinance. The deadline for the City to receive written comments regarding this Notice is 5:00 pm Pacific time on Tuesday, September 28, 2021. City staff will provide all written comments submitted during this comment period to EPA in accordance 40 CFR 403.11(b). The Ordinance is available during this comment period at <http://cityofhenderson.com/pretreatment>. The Ordinance is also available for review and copying at Henderson City Hall, Department of Utility Services Administration, 240 S. Water St., 2nd Floor, Henderson, Nevada 89015.

Written comments must be submitted to the City of Henderson, Department of Utility Services, using one of the contact methods below, and must arrive and be received by the City no later than 5:00 pm Pacific time on Tuesday, September 28, 2021. After written comments are considered, the Ordinance may be approved without changes or revised. The City's request to EPA to approve modification of the City's pretreatment program will be approved if no comments are received by September 28, 2021, no substantive comments are received, and the City's request is approved without change. See 40 CFR 403.18(c)(3).

A public hearing can be requested per 40 CFR 403.11 but must be filed during the comment period which will end on September 28, 2021. A request for such a public hearing must be submitted to the City using one of the three contact methods identified below.
