- Municipal Court Judge, Department III (6-year term)

The City Council shall meet at any time within 10 days after any election to canvas the returns and declare the result. [City Charter 5.100(2)]

The City Clerk, under his hand and official seal, shall issue to each person elected a certificate of election. The officers so elected shall qualify and enter upon the discharge of their respective duties at the first regular meeting of the City Council held in January of the year following the general municipal election. [City Charter 5.100(3)]
